

PRIVACY POLICY

Protecting your private information is our priority. This Statement of Privacy applies to the www.shareasale.com and ShareASale.com, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to ShareASale.com, Inc. include www.shareasale.com and ShareASale. The ShareASale website operates as an Affiliate Network Provider. By using the ShareASale website, you consent to the data practices described in this statement.

Collection of your Personal Information

ShareASale may collect personally identifiable information, such as your name. We may gather additional personal or non-personal information in the future. Information about your computer hardware and software may be automatically collected by ShareASale.

This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the ShareASale website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through ShareASale's public message boards, this information may be collected and used by others. ShareASale encourages you to review the privacy statements of websites you choose to link to from ShareASale so that you can understand how those websites collect, use and share your information. ShareASale is not responsible for the privacy statements or other content on websites outside of the ShareASale website.

Use of your Personal Information

ShareASale collects and uses your personal information to operate its website(s) and deliver the services you have requested.

ShareASale may also use your personally identifiable information to inform you of other products or services available from ShareASale and its affiliates. ShareASale may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

ShareASale does not sell, rent or lease its customer lists to third parties.

ShareASale may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to ShareASale, and they are required to maintain the confidentiality of your information.

ShareASale will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on ShareASale or the site; (b) protect and defend the rights or property of ShareASale; and, (c) act under exigent circumstances to protect the personal safety of users of ShareASale, or the public.

Use of Cookies

The ShareASale website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize ShareASale pages, or register with ShareASale site or services, a cookie helps ShareASale to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
